Shipments will be made FOB Plant of Origin (Stateville, NC). Freight billings are either:

- Customer Pick-up (CPU)*
- Collect when using a customer-specified carrier (please specify carrier on documents*)
- PAD, when using our designated carriers

STANDARD SIZES

The following are standard sizes for most products. Please call your sales or customer service representative for exact availability. Standard skid quantity for all products is 250 sheets.

LEAD TIME FOR STANDARD SIZES

- Standard sizes will ship within three (3) working days
- Cut-to-size orders will ship within five (5) working days
- Consult customer service for current inventory levels
- Rush orders are accepted; consult customer service for ship dates
- See additional skid charges below

* Rolls are available for GATOR-PLY 30809 and GREEN GATOR-BACKER 30819 with up to four (4) week lead time.

Standard sheets are billed at actual size (49"x97"=33.007 square feet). Standard sheet sizes may be adjusted due to available paper stock at time of production. Material will be billed at standard sheet size.

Pricing will be confirmed on cut-to-size orders. Cut-to-size tolerance is +/- 1/8" in both length and width. Sheets must be ordered at the desired size. (Example: If 48"x96" sheets are required, 48" by 96" sheet size must be specified in the order.) Overruns on cut-to-size products will not exceed 5% per item.

LEAD TIME FOR LONG SIZES (99" up to 146")

The standard long sheet product is GATOR-PLY 30405 in the following stock sizes:

- 49" x 121"
- 49" x 145"
- 61" x 121"
- 61" x 145"

Standard lead time is three (3) working days on these standard long-sheet products. All other non-standard long sheet products will have a seven (7) day lead time. All long sheet orders require a 250 sheet minimum per line item. Overruns on cut-to-size long sheets will not exceed 5% per item.

ADDITIONAL CHARGES FOR LESS THAN MINIMUM QUANTITIES AND ADDITIONAL PALLETS

- A setup charge of \$3.50 per line item will apply to orders of less than 50 pieces
- A skid charge of \$45.00 will be applied to orders of less than 250 pieces
- 3A Composites USA reserves the right to skid customer orders in the most logical and economical fashion, including stacking various sizes on the same pallet.

STORAGE

Ideally, 3A Composites' products should be stored in the same environment as the cores and facers to allow each to reach equilibrium at the same relative humidity. This tends to minimize differences in expansion and contraction characteristics between panel components once they are combined. Storage area should not have excessive temperatures (in either direction) or moisture. This will help ensure the products perform at the highest level. All GATOR-PLY, LUXCELL & SYN-PLY products have an unlimited shelf life, but like all veneer type products, control of the above mentioned conditions is critical.
